The bottom line is that 71% of companies do not feel that their leaders are able to lead their organizations into the future. This is truly shocking, but what's even more scary is that:

- Only 18% of organizations feel their current leaders are "very effective" at meeting business needs.
- Only 10% of critical leadership roles have viable successors.
- Within 2 years, 48% of the workforce will be millennials.

Companies spend more money on leadership development than any other area of corporate learning. Yet the above results suggest that many of these dollars are ineffectively spent.
